The DCCC will not accept contributions from currently registered federal lobbyists, registered foreign agents, political action committees, or minors under the age of 16 for this event. Contributions from corporations, labor unions, and foreign nationals are prohibited under federal law. An individual can contribute as much as \$32,400 per calendar year to the DCCC's general fund for use at the DCCC's sole discretion. All amounts in excess of this (up to another \$32,400) will be for the DCCC's recount fund and will be used to pay expenses in connection with election recounts and contests. Donations to the recount fund will not be used for the purpose of influencing a federal election, and do not count against the contributor's biennial aggregate limit.
