RE: April 2016 Financial Statements

We are respectfully submitting the Democratic Party of Virginia's April 2016 Financial Statements for your review and consideration. In order to summarize and clarify April's financial activity, you will find our notes below. Should you have any questions or concerns, please do not hesitate to let us know.

- ➤ DPVA raised \$165,139.46 in the month of April which was more than our projected revenue of \$131,600. There are several DNC programs that have started to work in Virginia which brought our revenue up by \$60,611.50.
- > There are several notes regarding expenditures:
 - o Admin
 - Our health and dental insurance was more than projected by \$14,029.73 due to the ramp up the field program for the general elections. This is reflected in the offsets in the federal revenue and is budget neutral.
 - This month there is a penalty for the room block for the February Central and Steering meeting, which was \$3,376.34.
 - Finally, we caught up on our legal retainer and are paid to date for our retainers. Additionally, our retainer has increased from \$2,500 to \$5,000.
 - o Travel
 - Our travel expenses were under budget for the month of April by more than \$5,000.
- ➤ Unfortunately, due to a lack of non-federal funds we were not able to make a deposit into our savings account. We remain optimistic that we will be able to make contributions moving forward in subsequent quarters, but have amended our projections from 300K on December 31st to 135K.
- ➤ Our Federal Account Cash on Hand is \$8,689.31 and our Non Federal Account Cash on Hand is \$18,250.89 and the Non Federal Account still owes Federal Account \$109,524.75.
